RaisinBread respects your privacy and recognizes the importance of your personal information. We are committed to protecting your information through our compliance with this Privacy Policy.

This Privacy Policy describes the types of information we may collect when you visit the **RaisinBread** website or subscribe to receive the **RaisinBread** services (collectively, our “Services”) and our practices for using, maintaining, protecting and disclosing that information.

INFORMATION COLLECTION, USE AND SHARING

The only personal information about you that we collect is information you voluntarily give us. This information may include:

- Information you provide, such as your name, physical address and email address, phone number as well as your credit card or other billing information.
- Records and copies of your correspondence, including email address, if you contact us.
- Details of any other transactions you carry out through **RaisinBread** Services.

RaisinBread will only use your personal information

- for the purpose you provided it, such as to present the Services and its content to you,
- to notify you about **RaisinBread** events or services, and
- for the purpose of aggregated statistical analysis regarding how you and others use our Services. For any other use, we will first obtain your explicit consent.

RaisinBread will not sell your personal information to anyone. We will not disclose your personal information to any third party outside of our organization, other than:

- To contractors, service providers and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution or other sale or transfer of some or all of **RaisinBread** assets, whether as a going concern or as part of a bankruptcy, liquidation or similar proceeding, in which personal information held by **RaisinBread** about our users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law or legal process, including to respond to any government or regulatory request.
- To enforce or apply our Subscription Agreement and other agreements.
